As TTS ULUSLARARASI NAKLİYAT VE TİCARET ANONİM ŞİRKETİ, we show the utmost sensitivity to process and protect the personal data of our www.tts.com.tr visitors in accordance with the Personal Data Protection Law No. 6698 and its secondary regulations.

Within the scope of our company's disclosure obligation arising from the PDPL legislation, we would like to inform you about the cookies used by our Company and your personal data processed through this TTS Cookie Information Text.

Your Personal Data Processed Through Cookies

Which Types of Cookies Do We Use?

Cookies are small text files created by a website on your device and contain data in name-value format. Therefore, the cookies we use when you visit our Sites make it possible to store information about your site visit on your device and to use this information during your subsequent visits.

Cookies that are created by our Sites and can only be read by our Sites are primary cookies.

The content offered on our Sites is also provided through other domain names other than the domain name at the access address. In such cases, each domain name creates its own unique third-party cookies.

The types of cookies we use on our sites and the purposes for which we use these cookies are as follows:

1- Session Cookies

Session cookies are cookies that are valid during your use of our Sites and remain valid until you close your internet browser.

2- Persistent Cookies

These cookies are cookies that are stored in your browser and remain valid until they are deleted by you or until the expiration date.

3- Mandatory Cookies

These are cookies whose use is mandatory for our Sites to function properly and for you to benefit from the features of our Sites and the services offered.

4- Functional and Analytical Cookies

These are cookies that are used for purposes such as remembering your behavior and preferences during your visit to our Sites, using our Sites effectively, optimizing our Sites to respond to your requests and containing data about how you use the site. Due to their nature, these types of cookies may contain your personal data. By means of these cookies, for example, your preference for the display language of our Sites is processed.

5- Tracking Cookies

Tracking cookies are primary and third-party cookies created when you visit our Sites and third-party domains through our Sites. These cookies make it possible to track your click and visit history on the domains where they are created and to match these records between different domains. These types of cookies are processed and used for the purposes of collecting your preferences and behaviors and carrying out advertising and marketing activities by anonymizing them. In other words, we would like to state that we will not use such cookies to identify you or to make personalized decisions. Tracking cookies will only be used with your explicit consent.

We aim to provide you with a more efficient and functional internet experience with the third party cookies we use on our sites. A PDPL Confidentiality Agreement has been concluded between these third party service providers and our Company in accordance with the PDPL legislation and the security of your personal data obtained by these persons on behalf of our Company is guaranteed.

Storing and Accessing Cookies

Cookies created by our Sites are stored on your computer by your website browser that you use to access our Sites. The information contained in these cookies can only be accessed remotely by our Sites offered under the domain name (<http://www.tts.com.tr>) that created the cookie and only if you use the same browser.

It is up to You to Accept Cookies

Your Internet browsers usually automatically accept cookies used on the sites you visit. The use of cookies is not mandatory in order to use our websites, but if you set your browser to block all cookies, the quality of your user experience may decrease and may prevent you from accessing our Sites or utilizing various functions of our Sites.

You can configure your browser to block cookies for all sites or certain sites, to alert you when cookies are created, to block third-party cookies, or to count all cookies as session cookies.

On the other hand, you can delete cookies stored on your device through your browser or see and track the list and values of these cookies. You can get detailed information about cookie management by clicking on the browser you are using from the browsers listed below.

Website Analysis

Our website uses Google Analytics, a web analytics service of Google Inc. ("Google"), 1600 Amphitheatre Parkway, Mountain View, CA 94043, USA.

With your prior consent or in accordance with the above rules, Google will analyze your use of our website on our behalf. For this purpose, we use Cookies, including, but not limited to, those described in detail above. The information collected by Google when you use the website (e.g. referring URLs, information about which pages of our website you visit, your browser type, language options, operating system, resolution of your screen) will be sent to a Google server in the USA, where it will be stored and analyzed. The relevant results will be made available to us anonymously. In this process, your usage data may not be associated with your full IP address. The IP anonymization function offered by Google has been activated. With this function, the last 8 digits (IPv4 type) or the last 80 bits (IPv6 type) of your IP address can be deleted. Furthermore, Google has been certified under the EU-US Privacy Shield, which states that adequate protection for data processing in the USA is ensured.

You can withdraw your consent to website analysis at any time by installing and embedding the Browser Plugin program offered by Google or by managing your consent in the table above where the Cookie opt-out setting is located. Either way, this will prevent analysis of your use of the website, provided that you access the website from the browser in which you have installed the plugin and you have not revoked the Cookie opt-out.

Security of Your Personal Data

Cookies are not used for purposes other than those specified in this Cookie Information Text and all related transactions are carried out in accordance with the PDPL legislation. Your personal data obtained through cookies are processed, stored and secured by our Company in accordance with the PDPL legislation.

Your Right to Information

Within the scope of Article 11 of the PDPL Law, by applying to our Company, your personal data; (i) to learn whether it has been processed; (ii) if it has been processed, to request information about it, to learn the purpose of processing and whether it is used in accordance with its purpose, (iii) to know the third parties to whom it has been transferred domestically / abroad, to request correction if it is incomplete / incorrectly processed; (iv) to request its deletion / destruction within the framework of the conditions stipulated in Article 7 of the PDPL Law; (v) to request the deletion and destruction of your personal data within the scope of Article 7 of the PDPL Law and the correction of incomplete / incorrectly processed personal data. (v) to request notification of the deletion and destruction of your personal data within the scope of Article 7 of the PDPL Law and the correction of incomplete / incorrectly processed personal data to third parties to whom personal data is transferred; (vi) to object to the occurrence of a result against you due to the analysis exclusively by automated systems, (vii) in case you suffer damage due to unlawful processing, we inform you that you have the right to demand compensation for the damage.
